



9.30.21 **final** reporting of Emergency Financial Aid Grants to Students

This is the **final** report of student funds received as designated below. There were no expenses for the period 7.1.2021 - 9.30.2021. The following information must appear in a format and location that is easily accessible to the public. This information must also be updated no later than 10 days after the end of each calendar quarter (September 30, and December 31, March 31, June 30) thereafter, unless the Secretary specifies an alternative method of reporting:

Anabaptist Mennonite Biblical Seminary received its HEERF III Grant Award Notification on June 1, 2021. Anabaptist Mennonite Biblical Seminary will use no less than \$31,994 (the student portion) of the funds received under Section 2003(a)(1) of the Act CFDA 84.425E Allocation to provide Emergency Financial Aid Grants to students.

The total amount of funds that Anabaptist Mennonite Biblical Seminary received from the Department is \$31,994 pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs. .

46 students received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

(6) The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.

The method used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs, was by specifying the DoE's criteria on the application, and then applying an algorithm that was uniformly applied to all students who applied as delineated in the application.

(7) Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

All students at Anabaptist Mennonite Biblical Seminary were informed of the opportunity to apply for these grants through the Announcements which go to every single student's email. Follow through emails and text messages were also used encouraging eligible students to apply.
